2021 IHCC Class Titles & Descriptions

Blue Cross of Idaho: *Blue Cross of Idaho's Building Blocks to Enhance the Provider Experience*

This session will cover a brief overview of the True Blue Special Needs Plan (TBSNP) updates for 2021. We will also cover how to improve your success with prior authorizations and reduce the need for post-service appeals, guidelines for better supporting medical necessity, updates for completing the required annual mandatory training, and open discussion for simplifying the provider journey.

CMS Medicare: *CMS Current Priorities*
